Introduction

The present study aims to provide an overall description of the economic situation, foreign and particularly Greek investments, industrial relations and collective bargaining in Romania. It is developed in the framework of the European project "New EWC Directive – New Perspectives", implemented by OBES and financed by General Direction of Employment, Social Affairs and Equal Opportunities.

Romania is situated in the Southeastern Europe, in the Northern part of Balkan Peninsula, inside and outside of the Carpathians Mountains, on the Danube lower course, bordering the Black Sea.

Reforms and economic development

Type of economy

Since early 1990, Romania has had a free market economy despite continuing government presence in the industrial sector. Successive governments have taken steps to liberalise and privatise the economy.

Romania sits on the crossroads of many historic trade routes that allow access to another 200 million consumers within a 1,000-km radius of Bucharest. The main channels of these routes are the Danube river and the port of Constanta, one of the largest ports on the Black Sea, which is linked to the North Sea by a new navigation route through the Rhine-Main-Danube Canal. Romania has a large skilled workforce experienced in areas such as engineering and manufacturing and cheaper labour costs compared to many other East European countries. Many of the country's big cities boast of a large industrial infrastructure, which along with Romania's considerable natural resources offer substantial potential for exploitation and development.

General economic trends

Like many countries in Eastern Europe and the former Soviet Union, Romania had been struggling to turn its command economy into a market economy. Successive governments have found it difficult to turn the economy around because of a lack of hard currency and the inability to secure external funds due to the country's high budget deficits, much of it accrued from financing loss-making state industries. Old economic and financial structures have been slow to change just like the bureaucratic culture inherent in many old institutions. In the last ten years, the overall business climate has improved and the economic indicators look healthier. Romania's economy is growing and managed to overcome the global crisis of 2008 and returned to growth. Romania is an upper-middle income country economy.

Leading industries

Manufacturing and engineering are Romania's backbone industries. The country also possesses substantial energy resources and agricultural land. Most sectors of the economy remain under-exploited and offer great potential, particularly manufacturing, agriculture and tourism. The technology sector continues to play an increasingly important role in the economy due to the high level of skill among its workers and rather low wage costs. The real estate sector also offers significant growth opportunities.

Sectors that attracted foreign investment in recent years include oil and natural gas, automotives, metallurgy, banking and finance, food processing, heavy engineering, telecommunications, construction and consumer goods manufacturing. Investors have expressed interest in newly-privatised industries as well as in greenfield projects.

Government-owned industries and privatisation

Romania's government has reaffirmed its commitment to privatise the remaining state-owned companies, particularly those in energy, heavy industry, pharmaceuticals and utilities. The relevant privatisation strategies are formulated, approved and executed every year by the concerned ministries in collaboration with the state privatisation authority, the Authority for the Disposal of State Assets (AVAS). Most of the companies up for privatisation are listed on the Bucharest Stock Exchange. Privatisation is often carried out on these markets through electronic auction, public equity offer and/or firm commitment underwriting. Moreover, in the case of big state-run companies undergoing privatisation, direct negotiations are a common practice.

Foreign investors have showed a special appetite for the automotives sector, electronics and household appliances, construction, pharmaceuticals and bio-diesel production. Automotives was appealing to investors because of its long tradition in Romania. Production of consumer electronics and household appliances benefits from the ample availability of skilled workforce. The construction sector flourished due to the continuing boom in the real estate market and bio-diesel production benefited from large areas put to fuel-yielding crops.

The Information Technology and Communications (IT&C) sector has also attracted foreign investment due to the availability of highly qualified IT specialists.

Greek Investments

Over the past years, Greek investments in Romania have increased considerably despite a number of lingering issues mainly related with bureaucratic red tape. Greek investment activity covers a broad range of economic sectors, such as banking, telecommunications, consultancy and financial services, construction, food and beverages, shipping, textiles, IT, insurance, packaging, plastics, pharmaceuticals and cosmetics.

Greek investments to Romania amounted to EUR 1.91 billion at the end of January 2011, according to statistics from the Romanian Trade Registry (ONRC), which makes Greece the fifth largest investor in Romania. There are almost 5,000 Romanian companies with Greek shareholders.

The on-going economic crisis in Greece has a major impact on Greek investments in Romania. In the banking sector the local subsidiaries of Greek banks hold about 16 percent of the Romanian banking system's assets and are closely monitored by the Romanian Central Bank (BNR). Despite political reassurance that the Greek banks will maintain their positions in Romania, analysts say that some of them may have to restrain their exposure, if they will have less support from their groups.

On the other hand, Greek telecom company OTE has recently decided not to buy out the remaining 46 percent stake in Romanian landline telephony operator Romtelecom, held by the Romanian state, deeming the moment "inopportune", due to unfavorable economic conditions in Greece.

Success Stories

Cosmote Romania

Stepping into a market clearly dominated by telecom giants Orange and Vodafone, officials at Greek mobile operator Cosmote Romania were bracing up for a fierce battle back in 2005, when the Greek company relaunched the then defunct Cosmorom.

Almost one year and a half later, Cosmote saw a constant and rapid growth. By exploiting market niches with tailored services, the company managed to get a seven per cent market share in just one and a half years.

"We are a new company in Romania, we came in at the end of June and started operations at the end of the year and we had to face lots of problems because of the bad inheritance of Cosmorom," said CEO Nikolaos Tsolas. "We are dedicated, innovative, aggressive and we managed to succeed. In our first year of operations we accounted for 1.2 million customers and achieved a seven per cent market share, facing two giants and tough competition.."

Employing 700 people, Cosmote posted revenues of 43.8 million Euro in 2006, with net losses standing at 65.7 million Euro. Out of the 1.2 million customers the company caters for, 80 per cent are prepaid customers.

After acquiring Zapp Mobile Cosmote Romania has launched 3G services and mobile broadband Internet that can be purchased in 11 cities and are available in 300 localities. Subscriptions for data transfer speeds are up to 21.6 Mbit/s.

Global Finance

Romania still has plenty of room for expansion in the real estate market for investment fund Global Finance, which has invested more than 100 million Euro to date in Romania's real estate field.

Global Finance also has a track record of doing business in Romania, having invested in companies such as Axxon, Chipita, Delta, La Fourmi, Neoset, Orange, Sicomed, Titan/Moara Loulis and TotalSoft. The CEO of Global Finance, Costel Postolache said: "Global Finance will continue its commitment to sustain companies with a great potential in a market with such an immense promise." Global Finance manages several investment funds with a big chunk of money dedicated to Romania, including Global Emerging Property Fund, which initially raised a total capital of 150 million Euro in June 2005. It also launched South-Eastern Europe Fund (SEEF) in February 2006 and raised 197 million Euro at its first closing. The fund plans to raise more than 300 million Euro in total with subsequent closings. SEEF will first consider investing a controlling stake in companies which, according to Global Finance country manager Stefan Bucataru, have unused potential and regional expansion opportunities, targeting dynamic and extrovert companies, with regional development strategies

Piraeus Bank Romania

For companies expanding from Greece, the most obvious place to spread out was in the Balkans and, as one of the largest markets in the region, Romania was an obvious target. Piraeus Bank Romania has sped up its branch openings all over the country and diversified into brokerage, with real estate funds also on the agenda.

"Many of Piraeus Bank's Greek corporate customers expanded their operations in Romania and they needed a bank they knew well and whom they trusted to serve them in the region," said CEO Stavros Lekkakos. "Piraeus Bank is indeed one of the most dynamic and active financial institutions in Greece and the Balkan region, where it has recorded an exceptional growth during the last decade."

Piraeus Bank now operates 187 branches and 168 ATMS. Piraeus Bank has an active presence in this market since 2000.

Stirom

Taking over a Romanian state-owned company and keeping it profitable was a real challenge for the Greek investors in glass manufacturer Stirom. The Greek investors came to Romania at the end of 1999 and, in 2003, bought Stirom. Since then the firm invested 50 million Euro and now has a market share of 50 per cent in Romania.

"We have raised a lot of local suppliers because we think we have to help the economy," said Nikolaos Barlagiannis, general manager of Stirom. "We prefer to work with them even though sometimes this means higher costs. I believe in this country, the business environment is very stable, potential is very good and I think we will be here for many years to come."

Industrial Dialogue

Labour market institutions

In the context of government restructuring, the Ministry of Labour, Social Solidarity and Family has undergone a reorganisation process, culminating in the creation of a new ministry, the Ministry of Labour, Family and Social Protection. According to the decision on the organisation and functioning of the new ministry, the National Employment Agency assumes the tasks of the Department for Labour Abroad which had functioned within the former ministry.

The Ministry of Labour, Family and Social Protection (Ministerul Muncii, Solidarității Sociale și Familiei) is a specialised central public administration body, playing a synthesis role and in charge of devising and applying labour and social protection, as well as solidarity policies and strategies.

The National Employment Agency (Agenția Națională pentru Ocuparea Forței de Muncă), is in charge of the practical application of employment, vocational training and re-conversion policies, administration and granting of due entitlements, in compliance with the law on unemployment.

These new regulations are meant to enhance the structure of strategies, policies, regulation, synthesis and harmonisation of the EU legal framework with that of MMFES. They also stipulate and complete the executive functions of ANOFM on the domestic labour market, as well as on the labour markets of other countries.

Trade Unions

Union density is relatively high in Romania with up to half of all employees in unions, although the figures are very uncertain. The structures are fragmented, with five separate confederations, CNSLR-Frăția, BNS, CSDR, CNS Cartel Alfa and Meridian, each with a substantial number of affiliated federations.

There are probably between two million and two-and-a-half million trade unionists in Romania, although the figures are not precise. As a result estimates of trade union density vary. The unions estimate current density at 48% to 50%, while a study published by the employers association UGIR-1903 in 2005 calculated that 44% of employees were union members in 2002. However, a comparative database of union membership gives a lower figure, putting union density in Romania at 33.7% in 2006. This is still above the EU average but is well below the current estimate from EIRO, which takes the union estimates and puts union density at 50%.

There are currently five main union confederations and there are no precise figures on their membership. CNSLR- Frăția, which states on its website it has more than 800,000 members, is certainly one of the largest. It developed from a merger of the former official trade union movement (CNSLR) with another confederation (Frăția) in 1990. CNS Cartel Alfa, which was set up in 1990, is another major union confederation. An EIRO report on trade union membership, estimated that it had 400,000 members in 2008. However, Cartel Alfa disputes this, and its website states

that it has one million members. The EIRO report places BNS, which had its founding congress in 1991, in third place in membership terms, with 375,000 members in 2008. CSDR, which emerged after a spilt in CNSLR-Frăția in 1994, appears to be the next largest; the EIRO report estimated its membership at 345,000 members in 2008. And the smallest of the five, with around 170,000 members in 2008, according to the European Foundation, is CSN Meridian, set up in 1994.

These five confederations are all classed as representative at national level, giving them the right to negotiate national collective agreements. All five are members of Romania's tripartite economic and social council, the CES. Confederations must meet certain criteria in order to be classed as nationally representative. These include having members in at least half of Romania's administrative districts and in at least a quarter of its industrial sectors. In addition, a nationally representative confederation must have at least 5% of all employees in membership (see section on collective bargaining for more details).

In 2007 an attempt was made to establish a much more unified structure for the majority of Romania's trade unionists. Three of the five confederations – CNRLR-Frăția, BNS and Meridian – announced in January 2007 that they had agreed to form a new joint alliance – the ACSR, with a separate leadership structure, headquarters and legal personality. This also had the potential to resolve long standing disputes over the ownership of trade union assets, inherited from the period before 1989. However, one of Romania's largest confederations, Cartel Alfa never joined in the talks, arguing that the proposed merger could result in the loss of trade union "pluralism"; another, CSDR withdrew; and overall there appears to have been little progress towards a formal merger.

Collective bargaining

Legislation provides for negotiations to take place at national, industry and company level, as well as for groups of companies. The national level agreements are the most important in setting minimum terms and conditions. However, some company level agreements provide for significant improvements on the national minimum arrangements.

Two key elements of the legislative framework for collective bargaining are that agreements cover all employees involved, and that lower level negotiators cannot agree terms and conditions that are inferior to those agreed at a higher level. The result is that national level agreements, which are normally signed annually, cover all employees – in this sense collective bargaining coverage in Romania is 100% – and provide a minimum which can then be improved on in industry and company negotiations.

These national agreements set terms and conditions in some detail.

The national-level collective agreement is important because it sets the minimum standards in terms of pay and working time for the whole economy. The minimum wages agreed in sectoral- level collective agreements are higher than the minimum wages set at national level. In 2008, for example, in the transport and agricultural sectors, the negotiated minimum wage was 38% higher than the national level, in machinery manufacturing it was 36% higher, and in the wood industry it was 23%

above the national minimum wage. Similar differences may be observed in the collective agreements at branch level concluded in the past years in mass media, veterinary and food safety, chemicals, petrochemicals, utilities and real estate.

Regarding company-level agreements, enterprises usually adopt the sectoral-level minimum wages and only sometimes provide additional bonuses for the specific objectives and working conditions.

In relation to working time, some economic sectors – such as mining, manufacturing, transport and construction – have working schedules adjusted to the specificity of the activity and working conditions in the sector.

Large parts of the economy are covered by industry agreements; there were 18 valid industry agreements in 2006. However, these industry agreements often do little more than restate large parts of the national agreement and the improvements on the national agreement are often minimal. For example, none of the industry agreements valid in 2006 provided for annual leave above the 21 days provided in the national agreement.

At company level, although not at national or industry level, there is a legal obligation to negotiate – although not to reach agreement. The employer should initiate the process. This obligation applies where the company has 21 or more employees, and, out of the 24,300 companies or other types of organisation falling into this category in 2006, 11,600 had collective agreements. There are also agreements covering groups of employers, such as local transport operators. In some cases, where the union is strong – normally larger companies and often those with continuing state involvement – these agreements provide significant improvements on the national agreement. However, there are large numbers of companies where the agreements are essentially formal in character and do not improve on the national minimum arrangements. In addition, companies with fewer than 21 employees – a substantial proportion in Romania – are not obliged to negotiate and generally do not do so.

Collective agreements, by law, must be in writing and should be registered with the appropriate authorities – district in the case of company agreements, national in the case of industry and national agreements. There can only be one collective agreement for each bargaining group – in other words there cannot be competing agreements at industry level nor can there be separate agreements for different groups of employees in the same company.

As well as collective bargaining between employers and unions, there are also tripartite structures at national level, which bring together employers, unions and the government. The most important of these is the economic and social council, the CES, on which all five national representative unions have seats. In addition there have been social agreements signed outside the formal structures, such as the social stability pact in 2004, which covered a wide range of issues, including economic policy, healthcare and reform of the court system, as well as wages and employment. However, this agreement was only signed by CNSLR-Fratia and Meridian.

Workplace Representation

Employee representation at the workplace is through the unions, although legislation does provide for employee representatives to be elected if there are no union

members. Workplace union structures potentially play a key role in collective bargaining but they also have significant consultation rights.

Union organisations at the workplace are the main body for employee representation. And, although by law employee representatives can be elected where there are 20 employees and no union is present, in practice this is very rare. Legislation implementing the EU directive on a general framework for information and consultation, which was passed in December 2006, is unlikely to change the situation.

The arrangements for employee representation at workplace level are governed both by legislation and by clauses in the national collective agreement, which is legally binding on all employers (see section on collective bargaining).

Board-level Representation

Employee representatives have no right to be at board members in Romania, although they can attend board meetings for some items.

There is a single-tier board system and employees have no right to be board members. However, the law on trade unions states that elected delegates of the representative trade union (see section on unions) should be invited to participate in management boards to discuss "problems of professional, economic, social, cultural and sports interest". The trade union delegates do not have a vote but they should be given the agenda and access to the material to be discussed. They should be told of the board's decisions on the issues within 48 hours.

European – level representation

Romanian members of European bodies linked with European Works Councils and the European Company are chosen by the existing employee representatives, who, in the vast majority of cases, are the trade union representatives at company level.

European Works Councils

In 2005, the existence of a European Works Council was regulated in Romania by Law No. **217/2005**, which was published in the Official Gazette on 19 July 2005.

The Law 217/2005 includes 51 articles and entered into force upon Romania's accession to the European Union on 1st of January 2007. It transposed Directive 94/45/EC on the establishment of a European Works Council or a procedure in Community-scale undertakings and groups of undertakings for the purposes of informing and consulting employees. To eliminate discrepancies in the initial Law, the law has been amended with Ordinance no. 48/2006 on the modification of the Law no. 217/2005 on the establishment, organization and functioning of European Work Councils.

The Law No 186/2011 adopted on October 24th of 2011 and published in the Official Gazzette on October 28th amends and supplements the Law 217/2005 on the establishment, organisation and functioning of the European Works Council, in accordance with the Recast Directive 2009/38/EC.¹

Law 186/2011

The Law 186/2011 provides amendments to the transnatinality, to the content of information and consultation to the structure of the special negotiating body, to the content of the EWC agreement, to the facilitation of the function of the EWC (select committee, meetings of SNB, use of experts, training) and to the negotiations in the case of structural changes

The main changes are:

Transnationality

The scope of EWC is limited to transnational issues. The transnational character of issue taken into consideration refers not only to the group of undertakings as a whole or to at least two countries (article 1 par 4 of the directive), but also to the potential

effects of this issue on the European workforce or on transfers of activities in member states (recital 16 of the directive).

Article 2 of Law 186/2011

- (3) The transnational issues referred to in paragraph (2) shall mean issues concerning the Community-scale undertaking or Community-scale group of undertakings as a whole, or at least two undertakings or branches, subsidiaries or other secondary offices of an undertaking or group of undertakings situated in two different Member States.
- (4) The transnational character of an issue shall be determined by taking account, regardless of the number of Member States involved, of the level of management and representation that it involves, and the scope of potential effects on the European workforce or which involve transfers of activities between Member States.

Definition of "information"

A new definition of "information" has been introduced

Article 4 of Law 186/2011

"71. information – transmission of data by the employer to the employees' representatives in order to enable them to acquaint themselves with the subject matter under discussion and make an informed analysis; information shall be given at such time, in such fashion and with such content as are appropriate to enable employees' representatives to examine the issue properly and, where appropriate, to prepare for consultations;"

Definition of "consultation"

A new definition of "consultation" has been introduced

Article 4 of Law 186/2011

"8. consultation – the exchange of views and the establishment of dialogue between employees' representatives and the central management or any other level of management.

Consultation shall take place:

- a) at such time, in such fashion and with such content as are appropriate to enable employees' representatives to prepare an opinion;
- b) on the basis of the information provided to the employees' representatives about the proposed measures to which the consultation is related;
- c) without prejudice to the responsibilities of the management;
- d) within a reasonable time, which may be taken into account within the Community-scale undertaking or Community-scale group of undertakings;"

Elections of members in the SNB and the EWC

The proportion of the members of the SNB and the EWC are according to the new Law 186/2011 as follows:

Article 13

"In order to ensure continuity within the special negotiating body, under the terms of the rules of organisation and functioning, a reserve list shall be drawn up, by allocating in respect of each Member State one substitute per portion of employees employed in that Member State amounting to 10%, or a fraction thereof, of the number of employees employed in all the Member States taken together."

Article 24 par 2

"(2) The members of the European Works Council shall be elected or appointed in proportion to the number of employees employed in each Member State by the Community-scale undertaking or Community-scale group of undertakings, by allocating in respect of each Member State one seat per portion of employees employed in that Member State amounting to 10%, or a fraction thereof, of the number of employees employed in all the Member States taken together."

Meetings with the central management

When the subsidiary requirments are implemented the EWC has the right to meet without the central management concerned, before and <u>after</u> the main meeting.

Article 37

Before and after any meeting with the central management, the European Works Council or the select committee, where necessary enlarged in accordance with the third paragraph of Article 34 shall be entitled to meet without the central management concerned being present.

Elections of members in SNB and EWC

Romanian members of the special negotiating body (SNB) for an EWC are appointed by the existing employees' representatives. These are defined in the legislation as the trade union representatives, unless there is no union, in which case employees have a right to elect individuals to represent their interests. If there are no existing employees' representatives – either trade unionists or others – Romanian employees can elect the Romanian members of the SNB directly.

The same procedures apply for the Romanian members of an EWC set up under the fallback procedures in the annex to the directive (ETUI http://www.worker-participation.eu).

European Company

The Romanian Law on European Company Status transposed the 2001/86 directive was GD 187/2007 and came into force on March 2007².

Elections of members in SNB and SE representative body

Romanian members of the special negotiating body (SNB) for a European Company are appointed by the existing employees' representatives. These are defined in the legislation as the trade union representatives, unless there is no union, in which case employees have a right to elect individuals to represent their interests. If there are no existing employees' representatives – either trade unionists or others – Romanian employees can elect the Romanian members of the SNB directly.

The same procedures apply for the Romanian members of the SE representative body set up under the fallback procedures in the annex to the directive. The legislation does not deal with how Romanian representatives at board level under the fallback procedures to the directive are to be chosen (ETUI http://www.worker-participation.eu).
